 - i. First \$1 Million .6%
 - ii. \$1 million - \$2 million .55%
 - iii. \$2 million - \$5 million .5%
 - iv. \$5 million - \$10 million .45%
 - v. Over \$10 million .4%

- ❖ Trust Settlement (per year until completed)
 - i. First \$1 million 4% of FMV
 - ii. \$1 million - \$2 million 3% of FMV
 - iii. \$2 million - \$5 million 2% of FMV
 - iv. \$5 million - \$10 million 1% of FMV
 - v. Over \$10 million 0.5% of FMV

❖ <u>Irrevocable Life Insurance Trust:</u>
